**Tour Cost:** See page 6 of brochure. Total post-tour cost including guides, hotels, transportation and food is \$595 (single add \$245.) Please see basic tour registration for all other costs. A deposit of \$500 is required with your application. Final payment is due **January 15, 2007**. Tour cost is based upon current exchange rate and subject to change due to foreign currency fluctuation.

**Documents:** A valid passport is required.

**Cost of Tour Includes:** Round trip air transportation from Cincinnati to Prague and back to Cincinnati via Budapest. All land arrangements including all meals and admission fees as per the itinerary.

**Cost of Tour Does Not include:** Passports, all items of a personal nature, independent sightseeing, insurance, meals other than specified, soft drinks, coffee, tea, and alcoholic beverages with dinner or at any other time not mentioned as included. **Most tips and gratuities.**

**Accommodations:** Provided in 4 and 5 star hotels on the basis of two persons sharing a two-bedded room with private bath.

**Porterage:** Porterage of one suitcase per person is provided.
